- 11/8/2011** O.C. Board of Supervisors declares November as Grand Jury Awareness Month.
- 1/20/2012** **Extended Application Deadline**, 4:00 p.m.
- 1/20/2012** **Mandatory Orientation**, 3:00 p.m., conducted by the Court and Grand Jury at the Central Justice Center, Jury Assembly Room (3rd floor), 700 Civic Center Drive West, Santa Ana.
- 2/6/2012** Grand Jury Recruitment/Selection Committee meeting.
- 2/6-2/14/2012** Screening process by the Judges' Grand Jury Recruitment/Selection Committee to select approximately 90 of the most qualified applicants proportionately from the five O.C. Supervisorial Districts.
- 2/17/2012** Jury Commissioner confirms the list of approximately 90 applicants. Letters mailed to all applicants.
- 2/21-3/19/2012** O.C. Sheriff's Department conducts approximately 90 background investigations.
- 3/26-4/6/2012** Judges' Grand Jury Recruitment/Selection Committee members conduct interviews.
- 4/23/2012** Judges' Grand Jury Recruitment/Selection Committee meets to select 30 nominees, distributed proportionately from the five O.C. Supervisorial Districts.
- 4/26/2012** Superior Court judges vote to approve final list of prospective Grand Jurors by ballot (majority vote required).
- 5/3/2012** Letter from Judges' Grand Jury Recruitment/Selection Committee chair sent to all candidates. List of nominees released by the Court for publication.
- 5/9-5/10/2012** **30 nominees fingerprinted** at O.C. Sheriff's Department, Live Scan Office, 320 N. Flower Street, Santa Ana.
- 5/15/2012** **Drawing to designate 19 Grand Jury members and alternates**, 12:00 noon, Central Justice Center, Department C1.
- 5/21/2012** Deadline for members to apply to be foreperson of incoming Grand Jury.
- 5/29-5/30/2012** Judicial panel interviews foreperson candidates.
- 6/1/2012** Presiding Judge selects Grand Jury foreperson.
- 6/4, 6/5, 6/6 &
6/11/2012** **Mandatory Training** program for 19 members and first five alternates of the incoming Grand Jury conducted by the outgoing Grand Jury and their advisors.
- 7/2/2012** **Oath of Office Ceremony**, 10:00 a.m., Central Justice Center, Department C1. Discharge to outgoing Grand Jurors, and oath/charge to incoming Grand Jurors.
