- 1/31/2014**      **Mandatory Applicant Orientation**, 3:00 p.m., conducted by the Court, O.C. Sheriff's Department, and Grand Jury at the Central Justice Center, Jury Assembly Room, 3<sup>rd</sup> floor, 700 W. Civic Center Dr., Santa Ana 92701.
- 2/10/2014**      Grand Jury Recruitment/Selection Committee Meeting
- 2/10-2/20/2014**      Judges of the Grand Jury Recruitment/Selection Committee review applications to select no more than 90 of the most qualified applicants proportionately from the five O.C. Supervisorial Districts.
- 2/25/2014**      Jury Commissioner confirms top applicants and informs all applicants by mail.
- 2/26-3/26/2014**      O.C. Sheriff's Department conducts background investigations.
- 4/3-4/14/2014**      Grand Jury Recruitment/Selection Committee members conduct interviews.
- 4/18-4/28/2014**      Grand Jury Recruitment/Selection Committee members select top applicants.
- 4/30/2014**      Grand Jury Recruitment/Selection Committee members meet to select 25-30 nominees, proportionately representing the five O.C. Supervisorial Districts.
- 5/1/2014**      Superior Court judges vote to approve the final list of prospective grand jurors by ballot (majority approval required).
- 5/8/2014**      Letters mailed to all candidates and names of nominees released for publication.
- 5/14-5/15/2014**      **Nominees fingerprinted** at O.C. Sheriff's Department, Live Scan Office, 320 N. Flower St., Santa Ana 92703.
- 5/20/2014**      **Drawing to designate 19 Grand Jury members and alternates**, 12:00 noon, Central Justice Center, Department C1, 700 W. Civic Center Dr., Santa Ana 92701
- 5/23/2014**      Deadline for Grand Jury members to apply to be foreperson.
- 5/27-5/29/2014**      Judges interview foreperson candidates.
- 5/30/2014**      Selection of Grand Jury foreperson announced.
- 6/2, 6/3, 6/4, & 6/5/2014**      **Mandatory Training program for 19 members and first 5 alternates** of the incoming Grand Jury conducted by the outgoing Grand Jury and their advisors.
