

The role of a Grand Jury differs substantially from a trial jury. It is a fulltime assignment. Approximately 80% of time is spent in a civil watchdog role with remaining time spent in criminal indictment hearings. No jury trials and all proceedings are closed to the public.

<b>1/19/2024</b>	<b>Email to all applicants</b> regarding Applicant Orientation meeting.
<b>2/2/2024</b>	<b>Applicant Orientation</b> – 10:00-11:30 a.m., informational session with participants from the Court, O.C. Sheriff's Department, and Grand Jury at the Central Justice Center, 3 <sup>rd</sup> Floor Jury Assembly Area, 700 W. Civic Center Dr., Santa Ana 92701.
<b>2/6-2/15/2024</b>	Judges of the Grand Jury Recruitment and Selection Committee review applications and select no more than 90 applicants, proportionately distributed from the five O.C. Supervisorial Districts.
<b>2/23/2024</b>	Jury Commissioner confirms selected candidates and informs all applicants by mail.
<b>2/28-3/22/2024</b>	O.C. Sheriff's Department conducts no more than 90 background investigations.
<b>4/2-12/2024</b>	Grand Jury Recruitment and Selection Committee members conduct interviews.
<b>4/15/2024</b>	Grand Jury Recruitment and Selection Committee votes to confirm slate of 25-30 candidates to proportionately represent the five O.C. Supervisorial Districts.
<b>4/22-30/2024</b>	Superior Court judges vote to approve the final slate of 25-30 Grand Jury nominees (majority approval required).
<b>5/2/2024</b>	Names of the 25-30 candidates to be published and all candidates notified by mail.
<b>5/8-17/2024</b>	<b>Candidates Fingerprinted</b> – O.C. Sheriff's Department, Live Scan Office, 320 N. Flower St., Santa Ana 92703.
<b>5/24/2024</b>	<b>Drawing to Designate 19 Grand Jury Members and Alternates</b> – 11:00 a.m.-12:00 noon, at the Central Justice Center, 3 <sup>rd</sup> Floor Jury Assembly Area, 700 W. Civic Center Dr., Santa Ana 92701.
<b>5/29/2024</b>	Deadline for <b>Grand Jury Members</b> to apply to be foreperson, 4:00 p.m.
<b>6/6/2024</b>	Judges interview foreperson candidates.
<b>6/7/2024</b>	Name of Grand Jury foreperson is announced.
<b>6/11, 6/12, 6/13, &amp; 6/14/2024</b>	<b>Mandatory Training</b> – 19 grand jurors and all alternates attend orientation and training conducted by members of the outgoing Grand Jury and their advisors.
